



## Terms of services, Risk warnings and Disclaimer

### Our Fees:

Forex Gainer charges the following fees:

One time starting Management fee: 150USD Non refundable

Monthly Performance Fee: 30% Per Month from profit earned

### Explanation of the Performance fee and Profit Loss:

Performance means the profit that we earn from trading with your account in a month. We will charge 30% of that monthly profit, for example, if your account size is 1000\$ and we earn 100\$ profit on it in a month from closed trades on that account, then our performance fee for that month will be 30\$. This will be same for every month; if the profit is less, then we will get fewer fees, if the profit is more we will get more fees.

You will have to pay our performance fee within first 10 days of every month; otherwise we will stop trading in your account. Performance fee will only be taken from the profit every month. If for any months there is a loss in trading on your account and the balance is minus, we will not charge any fee.

### Explanation of the Monthly profit:

Forex gainer is not a bank or an investment company or a funds security firm and we do not have a monthly profit scheme. Your investment is directly with your broker and we do not advice on any investment either. We are just a Trading Account management company that trades on your behalf with your permission.

Our services are for traders who know the market well and are aware of the risks involved.

We only trade on your accounts that you have opened with your own choice of broker(s).

From the monthly performance of your account as a result of trading (profit/loss), we will only charge you a performance fee (30% of the profit per month). Any profit or loss for clients is made by trading (Account Management) on their account; therefore we don't have any fixed profit scheme or provide profit from our pocket.

### Passwords/Pin Code:

Your broker will provide systematically generated password, phone password and pin code exclusively to your registered email address and you will have the option to change those passwords as many times as you wish. You are advised not to share your password to any irrelevant person, if you do so it would be solely at your own discretion, Forex Gainer or its employee or agent will not carry any responsibility for any profit or loss that you may incur as a result.
